NEPAL

Nepal, the country in Asia is lying along the southern slopes of the Himalayan mountain ranges. It is a landlocked country located between India to the east, south, and west and the Tibet Autonomous Region of China to the north. Its territory extends roughly 500 miles (800 kilometres) from east to west and 90 to 150 miles from north to south. The capital is Kathmandu.

Nepal, long under the rule of hereditary prime ministers favouring a policy of isolation, remained closed to the outside world until a palace revolt in 1950 restored the crown's authority in 1951; the country gained admission to the United Nations in 1955. In 1991 the kingdom established a multiparty parliamentary system. In 2008, however, after a decade long period of violence and turbulent negotiation with a strong Maoist insurgency, the monarchy was dissolved, and Nepal was declared a democratic republic.

NEPAL & INDIA

Nepal and India enjoy excellent bilateral ties. Founded on the age-old connection of history, culture, tradition and religion, these relations are close, comprehensive and multidimensional and are pronounced more in political, social, cultural, religious and economic engagements with each other. To add up the formal flavor to such historic relations, the two countries established diplomatic relations in the year 1947. The unwavering commitment to the principles of peaceful coexistence, sovereign equality, and understanding of each other's aspirations and sensitivities has been the firm foundation on which our bilateral relations have been growing further.

Nepal's solemn desire to cultivate and foster the cordial and friendly ties with its neighboring countries is reflected in its long standing position of not allowing its territory to be misused by any elements unfavorable to India. The open border between the two countries remains a unique feature of our relations. Frontier without restriction has greatly facilitated the free movements of our people to each other's territory and enhanced interactions.

This company was registered as a private limited company under the Cottage and Small Industry Act of the Government of Nepal. Khajuri Foods has started with single product, baked bread (Pauroti). Khajuri Foods had been expanded in 1994 with diversified products, cookies and puff pastry. The brand name of Khajuri Foods has been changed in 2003 from Khajuri Foods to Khajurico Nepal.

The delegation led by Hon. Minister for Industries, Sports & Youth Affairs, Government of Kerala visited one of the factory of Khajurico Nepal Pvt. Ltd. located at Bagdol in Lalitpur, Nepal.



The delegation was welcomed by Mr. Omnath Maharjan, Chairman, Khajurico Nepal Pvt. Ltd. along with Managing Director and Directors of Khajurico Nepal Pvt. Ltd.

Shri. Jagannath Maharjan, Managing Director, Khajurico Nepal Pvt. Ltd. made a presentation about the company and products of Khajurico Nepal Pvt. Ltd. to the delegation. The company is constantly expanding its distribution and product offering to better serve the needs and opportunities that the competitive market place offers and demands.
