## MSME Clinics – Spearheading accelerated growth of MSMEs in the State

Formal Inauguration of MSME Clinic was performed by Hon. Industries Minister Shri. Rajeeve on 23rd March 2022. Industry Department officials from all the districts and subject matter experts empaneled for the MSME Clinic were present on the occasion. Industry associations representatives from KSSIA, CII, FICCI and others were also present at the meeting. It is hoped that the operation of this clinic will create a conducive ecosystem for micro, small and medium enterprises in the State.

There are currently 147000 Micro, Small and Medium Enterprises (MSMEs) in Kerala. The Department of Industries has been providing excellent support to entrepreneurs to start MSMEs and improve their operations. However, it was noticed that a few micro and small enterprises were facing difficulties in the areas of licensing, marketing and financing in the journey



ahead. MSME clinics have empaneled subject matter experts with experience in project reporting, licensing, law, marketing, exporting, banking, GST and technology. An expert group of168 subject matter experts have been provided in 14 districts of Kerala. The respective District Office or Taluk Office can be contacted for assistance related to MSMEs.

The key aim of theses MSME Clinics is to help entrepreneurs solve their problems and move them forward using the services of experts.



Technology clinics were also launched to introduce new technologies to entrepreneurs. The technology clinics run by the Department of Industries to introduce new technologies to e-entrepreneurs are getting a good response. So far, 6 technology clinics have been conducted online at the state level.

Introduction of latest technologies related to the construction sector in collaboration with Indian Institute of Infrastructure and Construction (Kollam, Chavara). Workshop on Bureau of Indian Standards and its other procedures. Introduction of technologies related to product packaging held in collaboration with Indian Institute of Packaging (Chennai).
